Training guidelines and indenture of the Buddhist Psychotherapy BPT ®

- 1) The title Buddhist psychotherapy ® is protected as a registered trademark patent. Within a BPT® training, the certificate of Buddhist Psychotherapy BPT® can be acquired.
- 2) Admission to training is open to people from the medicinal, health and social professionals, that is, people who work with people, and people with special aptitude.
- 3) After successful completion of training, the participant receives a certificate of Buddhist Psychotherapy BPT®. This certificate allows use of title: "**Buddhist Therapist BPT ®**".
It does not authorize as an instructor of Buddhist psychotherapy ® to act.
- 4) The Buddhist Psychotherapy ® is headed by Dr. Matthias Ennenbach. For training team suitable guest speakers are sometimes used.

5) Before beginning, until the same date, the applicant submits a written synopsis that describes the following aspects:

1- tab. CV, job-relevant training certificates / approvals.

2- What previous experience as a practitioner? What methods do you use?

3- What previous experience with the Buddhist teaching and practice?

4- What experiences have shaped your personality?

5- What expectations exist concerning the training? Why the title is sought?

6- What is expected / hoped for a personal benefit?

7- To what extent the activities of Buddhist Psychotherapy ® should be exercised during and after training?

6) Go to content and to the requirements of the training:

The content will be announced prior to the training.

7) The training candidates undertake to carry out the training dates. The training fees are charged for the entire training, not for individual modules.

8) Was an event for good cause failed, yet the final certificate can be completed. More than one event fails, the contents must be reworked. The implementation should be clarified in a personal conversation.

9) The training may be terminated by training candidates for important reasons, such as illness, etc. The notice shall be in writing with reasons. So far incurred fees will not be refunded, no need for further fees.

10) The training may be terminated by the training officer, if a participant themselves or others at risk or he significantly impedes the training process. So far incurred fees will not be refunded, no need for further fees.

11) Relevant to the training sequence diseases must be reported to the BPT trainers before signing up. The further course may then be clarified together.

12) There will be a final exam.

13) The cost of training the block method (10 days) will be due prior to the start of training.
